### ROLE PROFILE

The Render Capital Initiative focuses on investing in enterprises strategically positioned to advance the gospel. As the **Christian Impact Investing Intern**, you will play a key role in supporting the initiative's mission to steward resources toward transformative, gospel-centered impact. This internship provides a hands-on opportunity to work with faith-driven enterprises, analyze impact investment opportunities, and learn about the integration of faith-driven investing and mission advancement.

The ideal candidate will have a passion for the gospel, a strong interest in faith-driven impact investing, and the skills to conduct research, evaluate investments, and collaborate with stakeholders who share a vision of using capital as a tool to expand God's kingdom.

#### Research & Analysis

- Conduct due diligence on potential investment opportunities to assess their strategic alignment with the gospel mission.
- Analyze financial performance, scalability, and social impact of enterprises within the Render Capital Initiative's portfolio or pipeline.
- Stay updated on trends and best practices in Christian impact investing and mission-driven enterprises.

#### Investment Support

- Assist in the development of investment proposals and presentations for review by the initiative's leadership.

- Monitor the performance of existing investments, providing insights on both financial outcomes and gospel impact.
- Prepare detailed reports summarizing research findings, key metrics, and recommendations.

## Portfolio & Stakeholder Engagement

- Participate in meetings with faith-driven entrepreneurs to discuss their mission, strategy, and capital needs.
- Collaborate with the Render Capital team to ensure alignment of investments with the initiative's mission and values.

## Communications & Educational Materials

- Assist in content development that communicates the Render Capital Initiative's vision, impact, and outcomes to stakeholders, including reports, newsletters, and social media updates.
- Assist in planning presentations that highlight the work of the initiative.
